Permission and Use Terms and Conditions

The permission to use an image from the collection of the Northfield Historical Society is granted as long as the following conditions are met.

Permission must be requested in writing in a Request for Use Proposal. Possession of a Northfield Historical Society image does not constitute the permission to use it.

Permission is for one-time, one-project use only or as otherwise negotiated and agreed upon in advance between the Northfield Historical Society and the request parties.

The Society retains all rights to the images, and they may not be used for any other purpose than that listed on the Request for Use proposal.

Commercial users must pay for the use fee in advance of receiving a permission form signed by the Northfield Historical Society.

Credit must be given to the Northfield Historical Society with the appearance of each image and in the final screen credits as applicable for broadcast or non-broadcast film or video applications.

If the image is still under copyright and the copyright is not held by the Society, the requestor must seek permission from the creator of the work or from the current copyright holder. The Northfield Historical Society will provide the creator's name, if known.

The Northfield Historical Society assumes no responsibility for infraction of copyright laws, invasion of privacy, or any other improper or illegal use that may arise from reproduction of any image. In all instance that applicant agrees to hold the museum and its agents harmless against any and all claims arising or resulting from the use of this image and shall indemnify the museum and its agents for any and all cost and damages arising or resulting from any such unauthorized use.

Photographs may be cropped to suit design and layout, but they may not be altered, colorized, or drawn upon without a letter or permission in addition to a signed permission form.

The Society reserved the right to decline permission to collectors, publishers, producers and individuals who have not complied with these conditions.
